All raters should become familiar with the detailed directions before beginning to rate student responses.

Appendix A provides a performance levels chart that translates final scores into four performance levels. A conversion chart is also needed to translate a student's raw scores on the written and performance tests to a final score. This chart will be posted on the Department's web site http://www.p12.nysed.gov/assessment/. Conversion charts provided for previous administrations of this test must not be used to determine students' final scores for the 2019 administration of the test.

Appendix B provides four charts that link the individual questions on the test to the ElementaryLevel Science Core Curriculum Grades K-4. This core curriculum is based on the New York State Learning Standards in Mathematics, Science, and Technology.

## Detailed Directions for Rating Part II of the Written Test

Note: Teachers are no longer permitted to score their own students' responses.
This guide contains detailed directions and criteria for rating student responses to the questions in Part II of the written test. Raters should become familiar with the detailed directions and rating criteria before beginning to rate the student responses. Refer to the 2019 Manual for Administrators and Teachers for suggestions about organizing the rating process.

In rating the student responses, follow the procedure outlined below.

1. Familiarize yourself with the system your school is using for processing the answer papers and recording the student scores.
2. Have a test booklet on hand. Read each Part II question carefully. Note exactly what is required.
3. Carefully read the criteria provided in this guide for rating each question.
4. For most questions, examples of acceptable responses are provided. Acceptable responses include, but are not limited to, the examples given. Other responses that convey the same general meaning as those given in this guide should also receive credit. Raters must use their professional judgment to decide if the student's answer meets the criteria. You may find it helpful to discuss questionable student responses with other raters.
5. Acceptable responses separated by a slash (/) are considered to be the same response and should be counted for credit once.
6. To ensure the accuracy of overlays, select a printer setting such as full, actual size, or $100 \%$ when printing this document. Do not select the fit to page setting.
7. Discuss with other raters the requirements of each question and the rating criteria. When you are certain that you clearly understand the requirements and criteria, you are ready to begin rating the student responses.
8. It is recommended that you rate all the student responses to one question or group of questions before proceeding to the next question or group of questions. This method helps ensure that the rating criteria are applied consistently.
9. Students should not lose credit for incorrect spelling, grammar, capitalization, or punctuation.
10. For questions where there is more than one answer and a specific number of answers are required, (e.g., identify three materials, give two examples), if the student provides more than the required number of responses, score only the required number, in the order in which they appear.
11. Sometimes in questions where there is only one acceptable answer, the student will provide more than one answer. These must be considered on a case-by-case basis. If the second answer indicates that the student does not understand the question or is simply guessing, then credit should not be allowed.
12. Record the number of credits you allow for each question in the table provided on the back cover of the test booklet. The maximum number of credits for each question appears in the table.
13. When you have finished rating all the Part II questions, add the credits allowed for each question to obtain the total raw score for Part II.
14. Follow your school's procedure for transferring Part II scores to the student's scannable answer sheet. These are local decisions that depend on the answer sheet your school uses. Some schools will transfer a score for each Part II question while others may transfer a total raw score for Part II. Check to be certain that the student name on the test booklet matches the name on the answer sheet.

31 [1] Allow 1 credit. Acceptable responses include, but are not limited to:

- The $16-\mathrm{g}$ wood block floated instead of sank.
- A 2-g iron nail sank instead of floated.
— One object with a mass greater than 9 grams floats.
- The wooden block floated even though it was more than 9 g .
- The iron nail's mass is less than 9 g and it sank.

Note: Do not allow credit for responses such as "wood floats" or "metal sinks" or "the wooden block floated." These responses only refer to the material from which the object is made, and do not address mass, as stated in the hypothesis.

32 [1] Allow 1 credit for entering correct data in all three unshaded columns.
Example of a 1-credit response:

Note: Do not accept dates and masses that are correctly matched but not in chronological order.

33 [1] Allow 1 credit for July.

34 [1] Allow 1 credit for any value greater than $34^{\circ} \mathrm{F}$ but less than $56^{\circ} \mathrm{F}$.

35 [1] Allow 1 credit. Acceptable responses include, but are not limited to:

- so you get the proper nutrients
- helps control weight
- keeps the heart and other internal organs functioning correctly
— builds strong muscles and bones
— to not become overweight
- to live a long life
- to make you strong
- Eating only one type of food may not give a person all the required nutrients.

Note: Do not allow credit for "to maintain good health" or "to stay healthy" because this is implied in the question.

37 [1] Allow 1 credit. Acceptable responses include, but are not limited to:

- sense food
- remove food from the water
- filter food from the water
— sense predators/prey

38 [1] Allow 1 credit. Acceptable responses include, but are not limited to:

- The shell color can camouflage the crab on the sandy beach.
- The color of its shell can help it to hide from predators.
- It looks like the sand, and predators will not see it.

39 [1] Allow 1 credit. Acceptable responses include, but are not limited to:

- to provide a place to lay their eggs and raise their young
- to provide a shelter for the young
- to provide a safe area away from predators
— a safe place to sleep
— access to food/water
- enough space for baby birds to grow and thrive

Note: Do not allow credit for "to provide a home to live in" because the purpose of the nest is to protect and raise the offspring, not to be a home for birds.

40 [1] Allow 1 credit. Acceptable responses include, but are not limited to:

- They can use the vegetables for food.
— They can save money on food.
— cool and/or trap heat for the buildings
- creating a green/usable space that they didn't have
— to provide healthier/fresh food
- Plants provide oxygen.
- Plants remove carbon dioxide from the atmosphere.

Note: Do not allow credit for "it gets more sun/water," as this helps the plants, not the people.

41 [1] Allow 1 credit. Acceptable responses include, but are not limited to:
— The tree is blocking the sunlight from student 1.
— The shadow of the tree is covering student 1.

- She is shaded by the tree.
- She is behind the tree, out of the Sun.

42 [1] Allow 1 credit. Acceptable responses include, but are not limited to:

- perspire/sweat
— sunburn/turn red
- suntan
- get hotter/temperature increase
— get thirsty

43 [1] Allow 1 credit for heat energy or thermal energy.

44 [1] Allow 1 credit. Acceptable responses include, but are not limited to:
— wood
— plastic
— rubber
— silicone
— glass

45 [1] Allow 1 credit for electrical, electric, or electricity.
